#### Fee Schedule

- Case evaluations with an oral opinion: \$2,500
  - Includes
    - review of records
    - communication
    - oral opinion on case merit
- Written reports: \$1,500
  - Written reports can only be provided once a complete case evaluation is performed, and the case is deemed meritorious.
  - Includes
    - Affidavits of merit
    - Expert opinions
- Depositions \$500/hr
  - \$1,000 must be paid in full prior to deposition start by the deposing party(ies).
    - 2 hours of deposition time
    - further deposition time will be billed out at above rate
  - \$1,000 cancellation fee if deposition is canceled/moved from agreed upon date/time without 48 hours notice
- Deposition preparation: \$2,500
  - Required for deposition
- Testimony: \$3,000 (up to 4 hours)/ \$6,000 (4-8 hours)
  - \$3,000 cancellation fee if testimony is canceled/moved from agreed upon date/time without 48 hours notice
  - Time is portal-to-portal based (include travel and waiting time at venue)
  - Time exceeding 8 hours will be billed at \$500/hr rate
- Testimony preparation: \$2,500
  - Required for testimony
- Independent physical therapy examinations: \$3,000 (plus travel and material costs)
  - Includes report generation
- Travel (local within 45 minutes of home excluded)
  - All travel expenses to be paid by retaining counsel.
  - Travel time: \$250/hr (capped at \$2,500/day)
    - Portal-to-portal based
      - Home to destination and back.
